


Education is Not Enough

Activism vs Advocacy







Policy Advocacy

- Write letters to decision makers
- Testify at city council and county supervisor meetings
- Meet with key partners and decision makers
- Collect letters and signatures of support
- Educate community members on the need for policy change
- Collect data to support advocacy efforts (e.g., store observations)





Changing Social Norms After the Policy is Adopted





Why Campuses are Reluctant to Use Citations

- Wary of negative interactions with police
- Don't want to be overly harsh
- Low priority





THE SOCIAL APPROACH



The AIR Approach

"Enforcement is Everyone's Business"





AIR Approach

Pros

- Doesn't involve police
- Doesn't involve recruiting volunteers

Cons

- People are EXTREMELY reluctant to approach individuals using tobacco on campus
- When it's everyone's responsibility, it's no ONE's responsibility



30 People/ 30 Day Campaign

Promotional Kit

- T-shirt
- Copy of tracking form for faculty for flex credit
- Policy promoter button
- "I am a participant" 81/2
 x11 poster for office
- Smoke-free policy postcards
- List of FAQ
- Policy tear off sheets
- Instruction sheet





30 People/ 30 Day Campaign

Pros

- Highly visible increases awareness
- Staff and faculty volunteers to approach staff and faculty violators

Cons

- Sustainable for long run?
- May get harder to recruit volunteers over time
- Volunteers may become frustrated
- People usually prefer to approach tobacco-users as a group, rather than individually



Policy Ambassador Programs

- Campus 'rounds' or 'patrols'
- Pairs or teams
- Scripting
- Carry resources/materials

- Identification
- Hot Spots used for targeting
- Tracking experiences





Policy Ambassador Programs

Pros

- Does work to increase compliance on campus.
- Training (and pay) make the process much easier for the volunteers


Cons

- Need dedicated staff to recruit and train
 Ambassadors
- Stubborn tobacco-users come to realize that they have no actual authority
- Ambassadors can become frustrated or disheartened



Police/Security as "Ambassadors"

Provide training and reminder cards to campus police or hired security





Pros

 Authority figures make more of an impact

Cons

- Police have to be friendly to the idea or pay for security
- Still may have some determined tobacco users



PUNITIVE APPROACHES – NOT CITATIONS



Administrative Enforcement

- Student Code of Conduct
- Judicial Affairs
- Human Resources





Administrative Enforcement

Pros

- Doesn't involve police
- Doesn't involve recruiting and training ambassadors

Cons

- Can be more punitive than a citation – many would rather receive a citation than a report on their employment record
- No enforcer means no enforcement



Online Compliance Training



- Similar to traffic school
- May be used with or without a fine
- Quiz ensures violator watches the training
- Back-end details will be different for each campus



Online Compliance Training

Pros

- Adds "teeth" without the use of fines
- Policy Violators get to learn about tobacco industry tactics, the environmental impact of tobacco and other topics

Cons

- Needs an "enforcer" with authority
- Backend details have to get sorted out (who will follow up?)



Administrative Enforcement: BIT Program

- Behavioral Intervention Team
- All staff, faculty, and police are able to write a BIT report
- The BIT Team reviews the reports and recommends next steps.
- Next step is to refer to the Online Compliance Training



BIT Program

Pros

 Doesn't involve campus police

Cons

No one wants to write a BIT report for tobacco use



USING CITATIONS




Recommendations for Issuing Citations

- Include enforcement language in the policy
- Try education for 1-2 years first



Recommendations for Issuing Citations

Create Enforcement Plan





What data do you need before considering alternative methods of enforcement?



AB 795

Campuses have two options:

- Administrative Fine –
 Fine paid to the university
- Court Fine Citations through the County Court. Must first get approval through the City Attorney's Office or County Council.

Understanding AB 795

Using Citations and Fines to Enforce Smokefree Campus Policies in California's Public Colleges and Universities

The health risks associated with smoking and tobacco use are well known. Tobaccorelated disease is the leading cause of preventable death in the United States, accounting for an estimated 443,000 deaths every year, due to heart disease, cancer, stroke, emphysema, and other respiratory diseases.^{1,2} Secondhand smoke is also a leading cause of death, with the U.S. Centers for Disease Control and Prevention estimating that approximately 50,000 nonsmokers die every year from diseases caused by secondhand smoke.³

Colleges and universities throughout the United States are strengthening their tobacco use policies to protect the health and well-being of their students, employees, and visitors. Unfortunately, even with stronger smokefree/robacco-free policies, secondhand smoke may drift into buildings, cigarette litter may be a persistent problem on campus, and compliance with policies may be minimal. As a result, colleges may seek to increase compliance by issuing citations and fines to individuals who violate a campus tobacco use policy.





Administrative Fine

Pros

- Citations work!
- Can make fines very small (\$10 - \$25)
- Money can be used for enforcement and cessation
- Less severe than student code of conduct/ disciplinary letter from HR

Cons

- "Backend" logistics must get sorted out by police or administration
- Must create a process for mediation



CSUs Can Use Education Code

Education Code 89031

- CSU Board of Trustees can establish rules and regulations
- Allows CSU police officers to issue citations to individuals violating the smoke/tobacco-free policy.
- Misdemeanor
- Already included in the county bail schedules.





Going through the County Courts/ Using the Education Code

Pros

- "Backend" logistics are handled by the court system
- No mediation

Cons

- Court fees make citations more harsh
- Should tobacco-use be considered a misdemeanor?
- If you're not a CSU, you must first get approval from the City Attorney's Office





Policy Enforcement Tools and Resources

Campuses take two broad approaches to enforcement: educational approaches and punative approaches. Campuses typically spend the first year of a new policy focusing on educational approaches and then use punative approaches (citations and fines) as needed after that.
